President's Message

I think I'll go for a walk outside now The summer still calling my name (I hear you now) I just can't stay inside all day

They say April showers bring May flowers, but I think we've seen enough of the rain for this season. Broadmoor has never looked better and Summer activities can't get here too soon for all of us. If you haven't had a chance to walk around throughout the neighborhood, it's worth some time to walk by the restored lagoon and Tulip Jet fountains, the new benches on the green belt (some with ocean views) and the freshly painted and repaired buildings. We have been hearing from those who have seen these improvements and we've had nothing but praise and appreciation for the improvements to our quality of life.

The buildings and common area held up relatively well during the recent storms. Although it is difficult to modify the existing infrastructure, the board is exploring ways to improve drainage issues in areas that were impacted by the unprecedented inundation of rain water this year.

As mentioned in the last newsletter, five new small claims lawsuits have been filed against the association by two residents. Each plaintiff filed two suits that are duplicative of suits filed by the other plaintiff. At the preliminary hearing, the association asked the judge to consolidate the five cases and all five will go to trial on June 1. As with the three lawsuits filed by one of the plaintiff's against the association last year, the board does not believe there is any merit to these claims. Unfortunately, these spurious actions involve many hours of your board and management company's time and attention preparing for and appearing in court. It's unfortunate that we have a few owners who continue to create unnecessary work and expense for our community. The fumigation of our entire community is now complete, so hopefully we won't be tenting again for 10 plus years. We are now replacing the roofs for the last remaining stand alone garages. We are also in the process of repairing and replacing any missing or broken tiles on the roofs impacted by the painting and fumigation projects. Remember if you have any apparent issues with termites or roof leaks, contact Powerstone for assistance. Please do not contact Lang Roofing or Fenn Termite directly as this can result in you as a homeowner being charged for the service call if it turns out there is no common area problem.

On Saturday, June 3, from 1:00 to 5:00, Broadmoor will have a Taco Truck, music and other fun activities to officially celebrate the re-opening of the lagoon and the completion of the large-scale wood work and paint project. Plant Damage Due to Tenting

It is unfortunate that a side effect of fumigation is the burning and surface damage to several plants that were covered by the tarps – especially many of the bougainvilleas that were recovering beautifully after the painting project. Rest assured, it is highly likely that these plants will sprout new growth in a few weeks. If some plants don't survive, the landscape committee will work up proposals for replacements to present to the board. In the meantime, Harvest will trim back plants that have turned brown and rake down the dead leaves to improve their appearance. If you've been affected, we thank you for your patience as Father Time and Mother Nature restore our vegetation. We share your desire to keep Broadmoor looking green. – Land.Comm.

Lagoon Tulip Jets

On your next walk around the complex be sure to check out the new "tulip jets" and layer of river rocks recently installed by the board. These fountain fixtures replace the old drain line caps that had holes drilled in them that existed for decades.

Oversized Vehicles

A reminder to all homeowners and residents that under the association's parking rules, vehicles which cannot fit inside the unit's garage are not eligible for either an inside or outside parking decal (with the exception of vehicles grandfathered prior to 2018). Landlords should be sure to inform prospective tenants of this restriction before entering into any lease. Too often, a new tenant moves in only to learn they cannot park their oversized vehicle in the complex.

Sand in Pool and Hot Tub

Recently sand has been tracked into the pool and hot tub from people returning from the beach. The sand can clog and damage the filters and heaters. Please be sure to shower off before using the pool and hot tub, especially if you've been to the beach. Also, try to

scare away the ducks, herons and seagulls so they don't leave their droppings in the water and along the decking. Finally, be sure the gate pool is secured properly when entering and exiting the pool area.

The board has revived the association's long-dormant Social Committee. Volunteers have stepped forward to organize the first social event for Broadmoor residents and families. 
