## President's Message:

At Broadmoor we celebrate September, as it is the beginning of our new fiscal year. We look forward to a productive year of making major progress on the re-roofing project, catching up on deferred maintenance, and upgrading the landscaping and irrigation systems in various areas of the complex.

As you enter the complex, you have noticed the first building on Lazare that has been re-roofed. This has been one of the costliest buildings. The extent of the dry rot, termite damage, and rusted metal has caused this building to be one of the most expensive in ways of "extra" charges. Broadmoor was built in phases, our roofing contractor tells us that the roofs on the last phase were installed with less quality materials and sections of the roofs were not sloped as they should have been. Slopes have now been added. It is our hope as we re-roof the complex, that we will come across roofs with less underlying damage. As I have said before, we are over the estimated budget thus far in the re-roofing project.

We have learned this year that we have a new looming maintenance issue. The two bedroom units that are along Martin Lane and Bordeaux Lane have wooden entry stairs that lead to two residents. A few of these entries have wood that has deteriorated and they must be completely rebuilt, including the support structure underneath. We are looking at bids in the range of \$25,000 to \$30,000 to rebuild each entry. Hopefully, there are only a few of these entry projects, as they have not been anticipated. The Board will be approving a bid to reconstruct an entry on Martin Lane at the September board meeting.

Another issue that I hope we can tackle this year is the growing outside parking problem. We have owners and tenants that simply have too many

## Monthly Updates

### Cable Television Package Upgrade

Good news for all Broadmoor residents! The association has entered into a much more favorable bulk rate cable television package with Time Warner Cable for enhanced services at a lower monthly cost.

For years Broadmoor has contracted with TWC for basic "standard" cable television signal service which provides approximately 70 channels, the cost of which is included in your monthly assessment. In order to use that signal, however, residents have to rent either a set-top cable box (with or without DVR) or a digital adapter.

Our new contract now includes the following services:

- Starter TV (20 basic broadcast stations, PBS, community access channels)
- Standard TV (70 cable channels)
- Showtime Premium Networks
- One free set top box (with or without DVR)

The new services begin October 15, 2016. If you are not already using a set-top box, you should order one from TWC since it is now free! If you choose a DVR box, keep in mind that you will have to pay an additional fee for DVR service (currently \$12.99 per month). If you are already paying for a set-top box or Showtime, the charges for those services should cease on October 15. Call TWC at 866-550-3211 if you have any questions.

### Maintenance Committee

#### Wooden entryway and stairways

Many residents have a common area wooden entryway and stairways. The two inch thick by six inch wide top boards have a wooden support structure underneath and in some entryways these need to be replaced. Some or all of the lumber supporting the top deck boards has an excessive amount

of dry rot damage. Many of these top deck boards have been replaced because of dry rot and now the larger supporting lumber underneath needs to be replaced. This can be a costly repair depending on how much lumber needs to be replaced. The original wooden structure did not have pressure treated lumber that helps to combat dry rot. All of the repaired wooden structures will have pressure treated lumber. Currently we have received three proposals from contractors to make a repair at an entryway and stairway that is for two units.
